#### **Karl Deutsch Award**



The purpose of the Karl Deutsch Award is to honour a prominent scholar engaged in the **cross-disciplinary research** of which Karl Deutsch was a master, with a particular focus on recognizing outstanding scholarship in the field of global politics. The recipient presents the Karl Deutsch lecture at the IPSA World Congress of Political Science. The Karl Deutsch Lectures are published in the International Political Science Review. The award is made on the recommendation of the IPSA Committee on Organization, Procedures and Awards (COPA). It is supported by the Karl Deutsch fund.

# Karl Wolfgang Deutsch (1912-1992)

Born in Prague, Karl Deutsch immigrated to the US in the late '30s. He taught at the MIT, Yale, and Harvard. He assumed the role of President of IPSA from 1976-79. He was also President of the American Political Science Association and director of the International Institute of Comparative Social Research at the Science Center in Berlin. He passed away in November 1992.

#### **Deadline to nominate: 1 November 2022**

#### Prize: \$1,000 USD (1 recipient)

The prize includes \$1,000 USD, economy airfare and registration fee for the upcoming Congress. The award winner presents a lecture at the 2023 IPSA World Congress of Political Science.

Funding: Karl Deutsch Fund.

**Note:** The prize is contingent upon in-person attendance and lecture presentation at the 2023 World Congress.

#### **Guidelines for nomination**

# <u>Prize of the Foundation Mattei Dogan awarded by the International Political Science Association for High Achievement in Political Science</u>



The Prize of the Foundation Mattei Dogan awarded by the International Political Science Association for High Achievement in Political Science is to honour a scholar of high international reputation in recognition of her/his contribution to the advancement of political science, with a particular focus on recognizing outstanding scholarship on comparative studies of political elites. The prize is awarded at every IPSA World Congress of Political Science.

#### Nomination deadline: 1 November 2022

# Prize: \$3,000 USD and travel expenses (1 recipient)

The prize includes \$3,000 USD, travel expenses up to \$2,000 USD and registration fee for the upcoming Congress. The award winner presents a lecture at the 2023 IPSA World Congress of Political Science.

Funding: Foundation Mattei Dogan

Note: The prize is contingent upon in-person attendance and lecture presentation at the 2023 World Congress.

#### **Guidelines for nomination**

Nominations for the prize can be made by one of the following ways:

- a) by a national association of IPSA;
- b) by an IPSA Research Committee (RC);
- c) jointly by two or more IPSA members in good standing of at least two different nationalities;
- d) by an incumbent IPSA Executive Committee (EC) member;
- e) from outside IPSA, by established academic institutions active in political science.

Nominations must indicate the merits of the nominee and be accompanied by her/his biography and bibliography or listing of most important scholarly contributions. The nominations should also include letters of recommendation, signed by prominent scholars, as well as evidence on the impact of the nominee's scholarship as suggested in such indicators as the Social Science Citation Index, Google Scholar, or other appropriate and recognized indicators, over the prior 15 years.

The awards are made on the recommendation of the IPSA Committee on Organization, Procedures and Awards (COPA). Current officers of the IPSA Executive Committee and of the Council, as well as the officers of the Research Committees are not eligible for this award. Former IPSA officers become eligible four years after the end of their last mandate.

# **IPSA Guillermo O'Donnell Award for Latin-American Scholars**



The IPSA Guillermo O'Donnell Award for Latin-American Scholars is meant to reward a Latin American scholar with residence in the region who is working on pioneering and innovative research in Political Science. The award recipient is to attend the upcoming IPSA World Congress and present a lecture to receive the monetary prize. Remote participation will be possible only when the event is fully virtual for the Congress in question. The award will be awarded for the first time at the 2023 World Congress in Buenos Aires.

#### **Application deadline: 1 March 2023**

Amount: \$3,000 USD. Travel expenses are not covered.

#### Eligibility:

- a. Academic / Education criteria:
  - Early career scholars: recipient must have completed his or her PhD within the last seven (7) years.
  - No age requirement.
- b. Demographic / Geographic eligibility:
  - Latin American scholar with residence in the region
  - All countries in South America including Brazil
  - All countries in Central America including Mexico
  - All countries in the Caribbean Puerto Rico
  - Residence minimum of 5 consecutive years.

**Condition:** The prize is contingent upon in-person attendance and lecture presentation at the 2023 World Congress.

#### Applicants for the award are expected to submit:

- A curriculum vitae;
- Statement of the nature of their research and why their work is innovative;
- Letter of reference from an academic familiar with the applicant's work certifying his or her academic status and indicating his or her suitability for the award;
- Representative sample of their innovative research whose length should not be greater than a scientific journal article;
- Letter confirming institutional affiliation will be requested as a supporting document as proof of residence in the Latin American region;
- Proposals may be submitted in all IPSA official languages, as well as Spanish and Portuguese.

This award was established to recognize the work done by a scholar from the Global South whose scholarly contribution is focused on the relevant countries, regions and themes. The award also recognizes a cumulative body of work. It was awarded for the first time at the 2009 IPSA World Congress of Political Science.

# **Application deadline: 1 March 2023**

#### Amount: \$1,000 USD (1 recipient)

The prize of \$1,000 USD for travel expenses and registration fees for the IPSA World Congress for one winner. The cash prize is the total award; no further reimbursement is to be awarded to one winner. The award winner presents a lecture at the 2023 IPSA World Congress of Political Science in Buenos Aires.

#### **Guidelines for application**

The following are the criteria for the award:

- Recipients must originate from the Global South and whose scholarly contribution is focused on the relevant countries, regions and themes of the Global South.
- Global South countries are considered as non-OECD countries. Applicants from OECD countries listed below are **not eligible** for the prize:

# Applicants for the award are expected to submit:

- 1. a curriculum vitae,
- 2. a statement of the nature of the research project and an indication as to how it is of significance to the Global South;
- 3. a letter of reference from an academic familiar with the applicant's work certifying his or her academic status and indicating his or her suitability for the award;
- 4. a representative sample of written work whose length should not be greater than a scientific journal article

The IPSA Committee on Organization, Procedures and Awards (COPA) will assess candidates' written work. IPSA also invites related IPSA research committees to nominate candidates.

# **Stein Rokkan Travel Grant Award**



The Stein Rokkan Award is one of the IPSA travel grants that the association began offering its members in the early 1990s. The purpose of the Stein Rokkan fellowships is to assist a small number of graduate students to attend the world congress by covering their basic travel and accommodation costs. The recipients receive financial assistance towards travel and subsistence. The awards are made on the recommendation of the IPSA Committee on Organization, Procedures and Awards (COPA), and they are supported by the Stein Rokkan fund.

#### Stein Rokkan (1921-1979)

A promoter of social and political science, Stein Rokkan contributed greatly to the field of comparative politics, notably during his teaching years at Bergen University. He assumed the role of President of IPSA from 1970-73. He was also Vice-President of the International Sociological Association, Chairman of the European Consortium for Political Research (which he helped found), and President of the International Social Science Council.

#### **Application deadline: 1 March 2023**

#### Amount: \$1,000 USD (1-2 recipients)

The prize is of \$1,000 USD for basic travel and accommodation costs for the upcoming IPSA World Congress of Political Science. The monetary prize may be shared by two recipients.

**Note:** The award recipient is to attend the IPSA Congress to receive the monetary prize.

#### **Guidelines for application**

The following are the criteria for the award:

- 1. each candidate must be registered in a degree granting program;
- 2. normally candidates must be at the doctoral level but in exceptional cases where qualifications and money allow students at master's level may be considered;
- 3. candidates must demonstrate that their academic institutions and professors have bestowed on them high academic honour and esteem.

# Applicants for the award are expected to submit:

- 1. a curriculum vitae,
- 2. a statement of the nature of the research project and an indication as to how it could benefit from participation in the Congress;
- 3. a letter of reference from an academic familiar with the applicant's work certifying his or her academic status and indicating his or her suitability for the award;
- 4. a representative sample of written work whose length should not be greater than a scientific journal article;
- 5. a statement indicating financial need in respect of the costs of attending the congress.

The IPSA Committee on Organization, Procedures and Awards (COPA) will assess candidates' written work.



# Thedore J. Lowi First Book Award (APSA-IPSA)



The Theodore J. Lowi First Book Award has been established to honor Lowi's distinctive contributions to the study of politics. This award recognizes the author of a first book in any field of political science that exemplifies qualities of broad ambition, high originality, and intellectual daring, showing promise of having a substantive impact on the overall discipline, regardless of method, specific focus of inquiry or approach to subject.

**Application deadline: 1 March 2023** 

Amount: \$750 USD

Eligibility: Nominees must have published their first single-authored book in the previous calendar year.

**Requirements:** Nominators are responsible for shipping or sending books to the award committee (COPA) after submitting a nomination on APSA's website.

Books must have been published in the previous calendar year to be eligible for the current awards cycle (books for the 2022 award must have been published in 2021). Many books contain both a publication date and a copyright date, and these may differ. Eligibility is determined by the earlier of these dates that is printed with the publication information at the front of the book.

Books should be single-author works to be eligible for the Lowi Award. For a book to be eligible for the Lowi Award, it must be the first book ever published by the author. If the book is the author's first book about political science, but not the first book every published, it is not eligible.

Nominators are responsible for shipping or sending books to the award committee after submitting a nomination.
